



**TERMS AND CONDITIONS GOVERNING 1959 X COLLABORATORS  
GIVEAWAY CONTEST DECEMBER 2019**

**1. The Contest**

- 1.1 This contest (“this Contest”) is organised by the Government of the Republic of Singapore through the Ministry of Culture, Community and Youth (“MCCY”). By participating in this Contest, you agree to be bound by these Terms and Conditions, which shall form a valid and binding agreement between you and MCCY and to abide by the decisions of MCCY with regards to this Contest.
- 1.2 The participants of this Contest (“the Participants”) may submit their entries from 3 December 2019 (2100hrs). The deadline for entry is 31 December 2019, 2359 hrs (the “Closing Date”). Entries received after the Closing Date will be automatically disqualified.

**2. Eligibility**

- 2.1 This Contest is only open to residents in Singapore, who have a valid Facebook or Instagram account.
- 2.2 Participants must be a minimum of 18 years of age at the date of entry.

**3. Contest Details and Prizes**

- 3.1 This Contest shall be made up of 5 rounds of giveaway competitions. There is no limit on the number of giveaway competitions that Participants may enter into.
- 3.2 To participate in a giveaway competition, Participants have to answer the question posed in the Facebook or Instagram post by MCCY in relation to that giveaway competition, before the Closing Date. There is no limit on the number of responses the Participants may provide for each giveaway competition. However, each Participant is only eligible to win one prize per giveaway competition.
- 3.3 MCCY will, in its sole and absolute discretion select the winners for each giveaway competition.
- 3.4 The number of winners and the prizes for the giveaway competitions are as follows:

- 3.5 MCCY may replace, withdraw or cancel the prizes at any time without notice or liability.
- 3.6 Subject to Clause 4, the prizes will be sent to the winners of this Contest through mail service, by the respective collaborator brands.
- 3.7 Prizes are non-transferrable and non-exchangeable for cash or in kind.

#### **4. Notification**

- 4.1 The winners will be notified through Direct Message ("Notification DM") on Facebook or Instagram within 15 days of the Closing Date.
- 4.2 To claim their prizes, the winners have to respond to the Notification DM and provide MCCY with their full name, a Singapore mailing address, and contact number. A winner who does not respond with the information within 4 working days, shall be deemed to have forfeited all his/her rights to the prize. Persons who provide the personal data in this Clause 4.2 consent to the sharing of their personal data with the respective collaborator brands for purposes of delivery of the prizes at Clause 3.6 above.
- 4.3 All personal details submitted must be accurate and are subject to proof upon request by MCCY. MCCY reserves the right, at any time, to verify the validity of entries and the eligibility of the winners. MCCY may disqualify any entry that is not submitted in accordance with these Terms or which tampers with the entry process.
- 4.4 MCCY reserves the right to select another Participant to replace a winner who is ineligible, disqualified, uncontactable for any reason or who does not claim his/her prize within the timelines set by MCCY.

#### **5. Collection of Personal Data**

- 5.1 The Participants consent to MCCY's collection of the Participants' personal data (including their names, public Facebook or Instagram profile information and/or their answers to the giveaway competitions that they participated in).
- 5.2 The Participants consent to MCCY's use and disclosure of the personal data mentioned at Clause 5.1 to MCCY's advertising and promotional agencies for purposes related to this Contest and MCCY's future advertising and promotional purposes without additional compensation unless prohibited by law.

- 6.1 MCCY may change these terms or suspend/terminate this Contest without giving notice.
- 6.2 MCCY (including its employees, officers, agents and assigns) shall not be responsible or liable for any loss or damage relating to or arising from this Contest (including the suspension or cancellation of this Contest) or any prize awarded, regardless of the cause and reason, to the extent permitted by law. Except to the extent that they may not be excluded by law, no representations and warranties apply to this Contest nor in respect of the prizes.
- 6.3 MCCY's decisions in respect of all matters with this Contest, including the selection of the winners, are final and no correspondence will be entered into in relation to such decisions.

- 6.4 By opening a Facebook or Instagram Account and using any services, products or features of Facebook or Instagram for the purposes of this Contest (including without limitation, uploading any materials onto this platform), each Participant is fully liable and responsible for complying with all terms and conditions as may be imposed by these platforms, and MCCY shall not be liable in any way whatsoever for such account and usage. Comments, photos, and video responses posted to MCCY Facebook or Instagram page are also subject to the terms of use of these platforms.

MCCY reserves the right to delete or edit, without notice to Participants, any posts, comments, entries or content that MCCY deems, in its sole and absolute discretion, inappropriate or in violation of Facebook's or Instagram's Terms of Use.
- 6.7 These Terms and Conditions shall be governed by the laws of the Republic of Singapore and the Participants agree to submit to the exclusive jurisdiction of the Singapore courts.
